MINUTES OF THE MEETING OF THE COUNCIL HELD AT
7.00PM ON THURSDAY 2ND NOVEMBER 2023
AT ELTON VILLAGE HALL**

Councillors stated that whilst the future of the Village Hall and its Committee was subject to debate until such times as the Committee ceases to exist any responsibility for authorising repairs rests with them although Councillors felt there was no harm in a survey being carried out. It was RESOLVED that a meeting should be arranged with the Village Hall Committee as soon as is possible to discuss the future of the Hall and the Committee.

Matters discussed at the Gratton Paish Meeting which relate to Elton Parish Council including the water which runs on the lane adjacent Oddo Farm were raised. It was also reported that a No Caravan sign has been erected in Elton but no signs erected at any other access points. The Clerk undertook to seek an update on these matters.
