MINUTES OF THE MEETING OF THE COUNCIL HELD AT
7.30PM ON THURSDAY 4TH JULY 2024

80.24 APOLOGIES

Apologies were received from Cllr Swindell.

81.24 VARIATION OF ORDER OF BUSINESS

There were no variations made.

82.24 DECLARATION OF MEMBERS INTERESTS

Councillors were asked to consider any interests they may have on matters on the agenda.

83.24 PUBLIC SPEAKING

It was reported that the lamp post near Oddo Farm is leaning at a dangerous angle which could have been caused by subsidence. The Clerk undertook to report the matter to DCC.

It was noted that there are two very large potholes on Gratton Lane.

It was noted that there had been a significant spillage of slurry from Oddo Farm onto Gratton Lane recently which has been reported to DDDC and the Environment Agency.

Concerns were expressed about the visibility at the Cross Roads near Barker Barn where the verge is very overgrown. The Clerk undertook to report the matter to DCC.

Discussion took place about the recent noise disturbance from a local music festival and concerns were expressed that similar issues may arise from future events in the area. The Clerk undertook to write to the Licencing Department at DDDC and raise concerns about recent experiences and request details of how events are monitored and request contract details so that issues can be reported when nuisances are being experienced.
